# **Hunterdon Health Celebrates 2022 Accomplishments**

- In 2022, Hunterdon Health launched a five year strategic plan, rebranded from Hunterdon Healthcare to Hunterdon Health and introduced a new mission, vision and core values for the organization. The core values are: authentic, accountable, adaptive, inclusive, committed and empowered.
- In August 2022, Hunterdon Health unveiled a new website, hunterdonhealth.org. The new website was designed with the patient in mind. There you can find important information regarding our services, providers, careers and so much more!
- To improve our patient experience, we have been diligently working on our HCAHPS scores. Hunterdon Health was above the 90th percentile for doctor communication, staff responsiveness and communication with a nurse.
- Despite the COVID-19 pandemic beginning in 2020 and continuing throughout 2022, we achieved and sustained low hospital onset CDIFF cases, low SSI following colon procedures, and had zero CLABSI cases and zero MRSA cases, all of which were better than national and/or state benchmarks.
- Hunterdon Medical Center and the Hunterdon Medical Group offices were recognized for their Antimicrobial Stewardship practices. Hunterdon Medical Center also received the 2022 Gold Steward Award for the 2nd year in a row for their ongoing antimicrobial stewardship efforts. Hunterdon Health also received the 2022 Bronze Steward Award for their stewardship initiatives in the Outpatient Setting.
- Hunterdon Medical Group's primary care practices also received two American Heart Association
  outpatient program achievement awards in recognition of their commitment to reducing the risk of heart
  disease and stroke by improving Type 2 diabetes and blood pressure management. The awards recognize
  a commitment to following the latest evidence and science-based care guidelines.
- The American Heart Association recognized Hunterdon Medical Center's Mobile Intensive Care Unit (MICU) with the Mission: Lifeline® EMS Silver achievement award for its commitment to offering rapid, research-based care to people experiencing the most severe form of a heart attack, ultimately saving lives.
- On November 15th, Hunterdon Health employees, providers and local officials, gathered to mark the beginning of construction for Hunterdon Advanced Imaging at Clinton. The new imaging suite will offer patients the latest technology in medical imaging including: mammography, Dexa Scan, X-ray, CAT scan, Ultrasound and MRI (3T).
- Hunterdon Health once again received an "A" Hospital Safety Score® by The Leapfrog Group for patient safety.
- Hunterdon Health has received the "LGBTQ+ Healthcare Equality Leader" designation from the Human Rights Campaign Foundation (HRC). In its 15th year, the Healthcare Equality Index (HEI) is the national LGBTQ+ benchmarking tool that evaluates healthcare facilities' policies and practices related to the equity and inclusion of their LGBTQ+ patients, visitors and employees.
