

Hunterdon Health Foundation Stock Transfer Instructions

Donations of appreciated securities (such as stocks, bonds, or mutual funds) can be made directly to Hunterdon Health Foundation. This is a highly tax-efficient way to give that can help the donor:

- 1. Avoid capital gains tax. If you sell appreciated securities, you are typically subject to capital gains tax on the increase in value since you purchased them. By donating the securities directly to Hunterdon Health Foundation, you avoid paying this tax, as qualified nonprofits are exempt from paying capital gains taxes.
- Maximizing Charitable Deduction. You can generally deduct the full fair market value of the donated securities on the date of the gift (if you've held them for more than one year), subject to IRS limits.
- 3. Increase the gift's impact. By avoiding the capital gains tax, Hunterdon Health Foundation receives the full value of the appreciated asset, making your donation more impactful compared to selling the asset and donating the after-tax proceeds.

Consult a financial advisor or tax professional to tailor this strategy to your specific financial situation. If you wish to donate appreciated securities, you may provide the following instructions to your asset manager or complete the transaction yourself:

- You will see the following information on the page and click Donate Stock Today to enter the tool. Financial advisors completing information on behalf of clients can check the box indicating such on the first page of the tool.

When you donate securities, you make an outsized impact without taking money directly out of your bank account. Plus, neither you nor Hunterdon Health will be taxed on the gains for appreciated assets you donate.


